

ORDINANCE NO: 16-0-02
SPONSOR: BY PETITION (ORC. 723.04)
INTRODUCED: FEBRUARY 17, 2016

AN ORDINANCE VACATING A PORTION OF THE UNNAMED ALLEY RUNNING BETWEEN PARCEL NUMBERS 2301384 and 2301385, PURSUANT TO THE APPLICABLE PROVISIONS OF THE OHIO REVISED CODE, AND DECLARING THAT THIS ORDINANCE SHALL BE EFFECTIVE IMMEDIATELY UPON PASSAGE.

WHEREAS, a portion of an Unnamed Alley that runs between Parcel Numbers 2301384 and 2301385 is located in New Franklin; and

WHEREAS, the portion of the Unnamed Alley running between Parcel Numbers 2301384 and 2301385 is no longer needed by New Franklin; and

WHEREAS, a plat of the portion of the Unnamed Alley to be vacated is attached to this Ordinance; and

WHEREAS, both of the owners of the properties which abut the portion of the Unnamed Alley to be vacated have petitioned New Franklin Council pursuant to ORC 723.04 to proceed with the vacation; and

WHEREAS, a copy of the petition received by New Franklin is attached to this Ordinance; and

WHEREAS, ORC 723.04 allows the legislative authority to act on the petition after holding a public hearing on the proposed vacation; and

WHEREAS, Ohio Revised Code Section 723.04 allows the legislative authority to vacate any street, or part thereof, when the vacation will not be detrimental to the public interest; and

WHEREAS, the vacated portion of the Unnamed Alley will be split equally between the 2 abutting parcels; and

WHEREAS, all the abutting property owners have noted their written consent to the vacation by executing the attached consents; and


WHEREAS, Ohio Revised Code 723.06 allows New Franklin to dispense with notice and publication of the vacation as required by Section 723.07 because all the abutting property owners have executed their written consent; and

and any deliberation of this Council and any other Committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.


SECTION SIX:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of New Franklin. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.






TO THE NEW FRANKLIN MAYOR AND COUNCIL, CITY OF NEW FRANKLIN, OHIO:

Ohio Revised Code Section 723.04 allows abutting property owners to petition the legislative authority to vacate a street that is no longer used or needed for any municipal purposes. After receiving the petition, the legislative authority shall hold a hearing on the issue and upon finding that there is good cause for such vacation, that such vacation will not be detrimental to the public interest, that the street is no longer needed for any municipal purpose and that the vacation should be made, the legislative authority may by ordinance declare the street vacated.

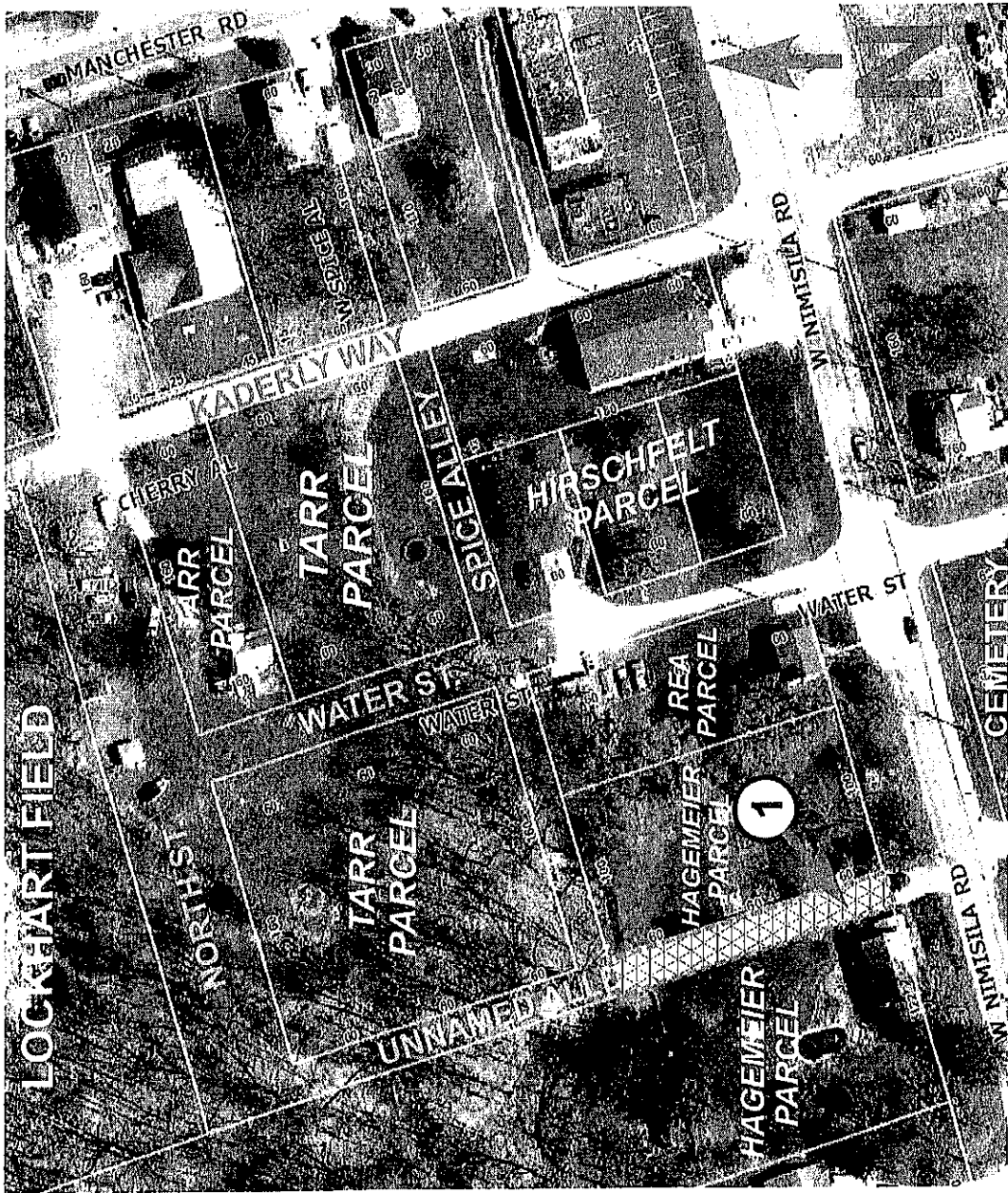
